**MINUTES OF ANNUAL MEETING
SOUTHERN DISTRICT OF IOWA BRANCH
OF THE HISTORICAL SOCIETY OF THE
UNITED STATES COURTS IN THE EIGHTH CIRCUIT**

June 10, 2016

The annual meeting of the Southern District of Iowa Branch of the Historical Society of the United States Courts in the Eighth Circuit was held on Friday, June 10, 2016, at 2:00 p.m. at the U.S. Courthouse, 123 East Walnut Street, Des Moines, Iowa. Present were President F. Richard Lyford, Vice President Anthony Gaughan, Treasurer Nancy Adams, Secretary Mollie Pawlosky, Judge Rebecca Goodgame Ebinger, Magistrate Judge Celeste Bremer, Magistrate Judge Ross Walters, Marge Krahn, Clerk of Court, Pro Se Staff Attorney Kay Bartolo, Intern Bessie Bauman, and Intern Madison Tuttle.

The minutes of the annual meeting held on June 19, 2015, and the 2015 Treasurer's report were approved. As of June 10, 2016, the Treasury has \$23,885.37.

The increase from the 2015 balance resulted from membership fees, and a \$10,000 contribution from the S.D. of Iowa Attorney Admission Fee Fund.

It was noted that Clerk of Court Marge Krahn is retiring on August 19, 2016. Ms. Krahn was commended for her service as Clerk of Court, and all in attendance wished her well in her retirement. John Courter, Chief Deputy Clerk of Court, will become the S.D. of Iowa Clerk of Court upon Ms. Krahn's retirement.

Regarding the sequel to, "No One is Above the Law," Judge Bremer reported that the basic content should be set by the end of summer, at which time Joe Weeg will then complete the sequel for \$5,000. The book will be published as an e-book, and the first volume will be scanned in as an e-book, as well.

Discussion was had regarding the success of the investiture for Judge Ebinger; Judge Ebinger provided a hardcopy photo and a digital photo of the courtroom to be used with the DVD of her investiture, and Judge Ebinger also showed those in attendance a posed, digital photograph of all judges that attended the investiture, which will be provided in digital format for use with the DVD, as well.

President Lyford reported that the oral history for Judge Walters has been completed, including editing. The histories for Judge Gritzner and Judge Pratt are


pending. The ceremonial session for Judge Fagg is also being produced. President Lyford received many compliments on how Judge Fagg's oral history was able to be used by Judge Colloton. The next oral history will likely be for David R. Hansen. Judge Ebinger agreed to approach Judge Melloy and suggest that she interview him for an oral history.

Vice President Gaughan reported on his progress with the biography of Judge Longstaff. The Branch agreed to continue support and assistance in this project. Vice President Gaughan and President will coordinate the effort, with the assistance of two of the judge's former clerks, Honorable Colin Witt and Tom Boyd.
